Concept: this test is intended to determinate the overall migration and specific migration in food water-based simulants of plastic materials intended to come into contact with food, by cell at selected temperatures and times.

- Simulant D1: Ethanol 50%
- Simulant D2: Vegetable oil

- 2 hours at 40°C
- Simulant contact by cell
